In Texas, you are NOT entitled to a court-appointed attorney UNLESS you are looking at jail time.

Do NOT trust AI answers on websites like Google! AND beware of sponsored ads on sites like Google – many may be outside the country & if you pay money you may not be able to recover it if they are scammers!

They offer you a discounted consultation with an attorney in your area -- Cost - \$20 for a 20-minute consultation

Through the Lawyer Referral Information Service, a person may have a brief consultation with an attorney for \$20. At the end of the consultation, the attorney and individual may discuss possible representation and price structure.

Their websites lists all Texas attorneys & if there have ever been disciplined or been disbarred for their "bad" behavior. Before you hire a lawyer, make sure that they are currently licensed in Texas to practice law. It also lists all pro bono (free) resources in Texas & there are free publications on their website If your attorney "disappears" you can use their website to try to locate them. They also have forms for grievance against your attorney.
